From Hwy 55, you will turn onto Sioux Dr, which is a very steep hill into downtown Hamel. This intersection does have a semaphore and is directly across from Target. At the top of the hill, you are looking directly at the Farmers Bank. You then take a slight jog to the right and then immediately left and follow that road back into the parking lot for the Community Building.
